

Boarding Agreement

This agreement pertains to the Horse/Pony described as follow:

In Witness whereof Boarder and Gwyn Meadows Farm, LLC the consideration herein named, hereby agrees as follows:

1. Gwyn Meadows Farm, LLC shall provide boarding for the horses of the Boarder.
2. Boarder will remit to in current funds, the amount of \$540.00 for ponies or \$550.00 for horses as the flat monthly board rate. Said amount shall be tendered in advance of the due date of the upcoming month. This amount shall not be subject to any refund, regardless of the date the stall is vacated.
3. Boarding will be limited to a minimum period (1) one month and Boarder may terminate this agreement without notice provided all fees are paid. Gwyn Meadows Farm, LLC may terminate this agreement at any time by giving verbal or written notice to the Boarder.
4. Gwyn Meadows Farm, LLC shall be entitled to a lien against the boarded horse or pony should the boarder fail to make payment in strict adherence to the terms set forth above. Upon removing said animal from Gwyn Meadows Farm, LLC premises, Boarder agrees to pay all outstanding invoices due Gwyn Meadows Farm, LLC in full.
5. Should it come to the attention of Gwyn Meadows farm, LLC that a boarded equine requires veterinary care Gwyn Meadows Farm, LLC is authorized to contact Dr. Peter Blauner and Associates and should that veterinarian be unavailable contact any other vet of their choice. Immediately following the staff of Gwyn Meadows Farm, LLC will contact you.
6. Gwyn Meadows Farm, LLC shall have the right from time to time to adopt and enforce safety and other rules the property and building in which will be strictly observed by the boarder.
7. I, the boarder, have contracted with Gwyn Meadows Farm, LLC for boarding purposes. It is understood and agreed that in no way is Gwyn Meadows Farm, LLC its employees, representatives or agents responsible or liable for the animal named above or tack equipment left at Gwyn Meadows Farm, LLC.
8. It is recommended the boarder have his or her own insurance coverage. Full mortality and major medical is recommended. You can contact E.P. Bishop for more information (609) 393-4339.
9. There is absolutely **NO JUMPING** on the property of Gwyn Meadows Farm, LLC without staff supervision.
10. The undersigned acknowledges that in consideration of being able to ride at Gwyn Meadows Farm, LLC and aware of the risk of horse related activities he/she assumes the risk of injury and agree that he/she will be responsible for and do hereby release Gwyn Meadows Farm, LLC from all liabilities including negligence by reason of injury to themselves or their property.

This document constitutes the entire agreement between boarder and Gwyn Meadows Farm, LLC written or verbal agreements exist to supersede it as evidence by signatures below:
